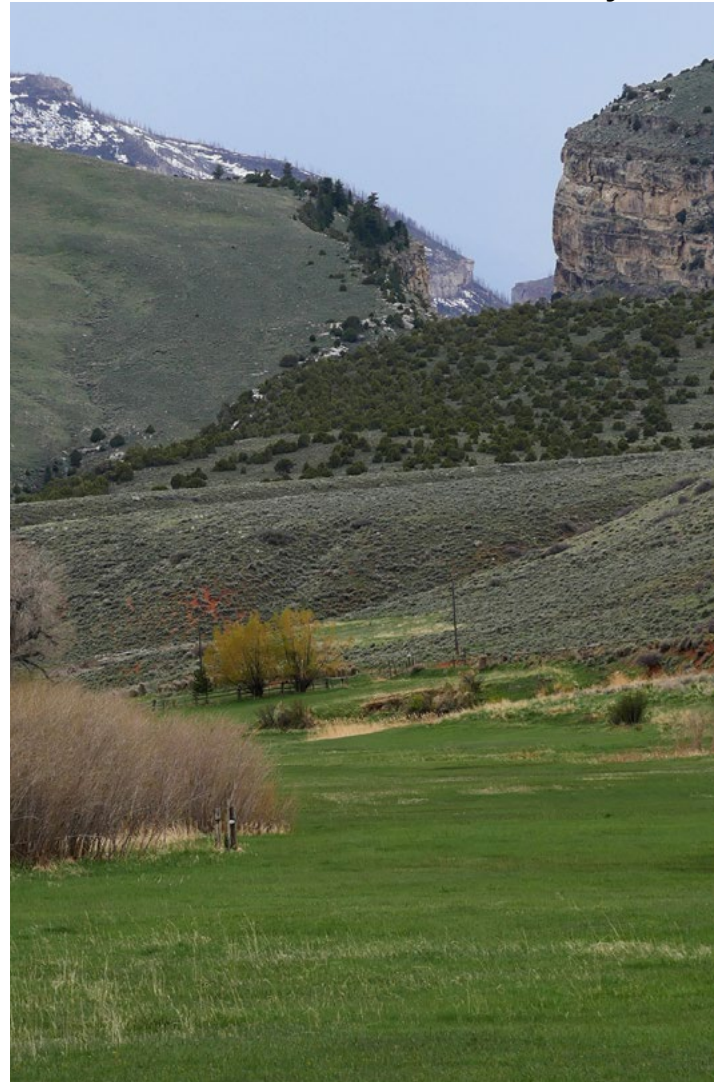

# Meet the Candidate...

## Rex Rammell

### Why Should Rex Rammell Be the Next Governor?

Thank you to Chairwoman Bennett for the invitation to address the Fremont County GOP. Thank you also to all those who helped with the Lincoln Day Banquet. I enjoyed the speakers, the food, and the camaraderie. It is nice to see Republicans united in a common cause.

I am a veterinarian from Rock Springs. I became interested in politics twenty years ago when I lived in Idaho. I ran for the U.S. Senate in 2008 and Governor of Idaho in 2010. 42,000+ republicans voted for me in the governor's race. My main issue back then, which has continued to this day is the public land transfer back to the states. After researching the issue for months in 2007, I came to the conclusion the federal government has no constitutional authority to control, let alone claim ownership to, over 25% of America's land mass. I authored my findings and conclusion in a book entitled, "A Nation Divided: The War for America's Soul." Since that time I became convinced that if the West could get control over the public lands it would not only change the destiny of the West, but also America. I believe it would be the beginning of a state's rights movement that would put the federal government back in its limited role on many subjects as defined by the Constitution. Once I knew what had to be done it has been my life's mission to make it happen.

I moved to Wyoming in 2012 and have done my best to make the transfer front and center in Wyoming. I received a standing ovation at the 2018 State convention when I addressed the subject by video, which is also on my website. The transfer is supported in the Wyoming Republican platform, but Republicans seem hesitant to campaign on the issue due to the relentless attacks by the left and by some within our party. However, I have been undeterred by the naysayers because I know unequivocally that it is the right thing to do.

The transfer has taken on more significance since Joe Biden signed his moratorium on oil and gas drilling on public lands, which is a major setback for the people of Wyoming and the nation. As serious as the moratorium is his 30 x 30 plan would be catastrophic. 30 x 30 is a plan to "conserve" 30% of America's land and water by 2030. The word "conserve" is the politically soft word for "protect." Protect is the word used to describe national parks, wilderness areas, permanent conservation easements, state parks, national wildlife refuges, national monuments, wild and scenic rivers, and other places taken out of multiple use.

The U.S. already has 12% or 272 million acres protected. 30 x 30 would add another 409 million acres under protection for a total of 681 million acres off the books for multiple use. What does that mean for Wyoming? I think we can officially kiss the fossil fuel industry goodbye for starters, but I think it would go much further. I believe grazing in the mountains is for sure on the list of things to stop along with much of our grazing on BLM ground. What logging remains would also be eliminated as more and more wilderness is set aside. Wildlife corridors would take whatever else remained. The 30 x 30 plan would be the biggest land grab by the federal government in U.S. history and would change the West as we know it. Instead of using the land for production we would become a bed and breakfast community for the rich.

What can we do about it? We can stop it by using the power of the Tenth Amendment. Our governor has the power right now to nullify all unconstitutional issues. Unfortunately, Governor Gordon stated he was "cautiously optimistic" about 30 x 30, so I don't think he will do much to stop it. However, if Rex Rammell is elected governor, by executive order the federal land managers would be escorted out of the state. Wyoming would with the governor's signature move all control over our public lands back to the state and 30 x 30 would become a mute issue.

That is why Rex Rammell should be the next governor!
